Community support has always been a core value at Allegra Cedar Rapids. Our FootPRINT Fund® awards print services to selected nonprofit organizations to help enhance their image, expand their services, and extend their budgets.

APPLICATION GUIDELINES

Who is Eligible? Our FootPRINT Fund® is available to any nonprofit charitable organization or association, headquartered in Linn County, IA meeting the selection criteria.

What are the Selection Criteria? Only 501(c)(3) organizations or associations may apply. Applications are reviewed by a panel of representatives from Allegra Cedar Rapids. Recipients are selected by committee, based upon how print services will be used to further their organization's charitable goals, including: Service Expansion, Program Enhancements, and Leveraged Efforts. Allegra's FootPRINT Fund Committee will review all applications that are submitted before the application deadline. Applications received after December 1st will not be considered for the following year's grant. Organizations should not assume an award has been given until such notification. Awardees will be notified and a complete list will be available on or before January 1st.

What is the Value of Services Awarded? Services are awarded with a maximum value of \$1,000 per organization for the award year. Applicants may be awarded services in the value of the amount requested, or in a lower or higher amount. Services include but not limited to graphic design, printing, copying and bindery. Applicants are encouraged to reapply the following year. All awarded print services must be used between January 1st and December 1st of the grant year. Awards may only be used for projects originating during these dates and not to offset any existing balances due to Allegra Cedar Rapids.
